Apple plants to be transported during the month of January-February 2024, fro m Palampur, HP to Imphal, and Aizawl. 6400 plants are to be delivered at each destination, 12800 plants to be transported in total.

Nature and Quantity of material: One-year-old plants in dormant state and without leaves. Plants are 2.0-2.5 feet in height. Approximate volume and weight may be calculated as per details given hereunder;

## i. Total number of plants = 12,800.

ii. 128 bundles each consisting of 100 plants (live plant material). Plants wrapp ed into a bundle of 100 plants.

iii. Each bundle weighing approximately 8 kg.

iv. Each bundle is in the shape of a cone.

v. Approximate height of each bundle is 80 cm and bottom/base circumference is 90 cm and bundles are sealed with packaging.

vi. To be delivered within 5 days from dispatch
