**1. Sh. Manish Kumar vide his representation dated 18-08-2022 has stated that:**



The main motto of his unit is to translate R&D Technology developed at Institute into business opportunities through Technology Transfer, Material Transfer Agreements (MTAs), Consultancy services, Academic and need based R&D collaborations and nurturing startups through incubation under "Chief Minister's Start up Scheme of H.P." This unit is involved in procurement of R&D services through floating tenders, economic and social impact analysis, organizing scientific & industrial meets for promoting technologies and their market outreach.

It was submitted also that he has exceptionally good track record but due to age criteria, have not been short listed and requested that considering his extensive work experience in this area, he may be given age relaxation for getting short listed for the post.
