1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Annexure-II (AMC 2023-24)

Broad terms and conditions for AMC shall be as under:-

1. The bidder shall attend to the call for the mentioned items for normal functioning within 1-2 hours after receipt of communication from the Institute. In addition, preventive and remedial maintenance for normal functioning of the computer should be done on routine basis.

2. The bidder shall depute one experienced engineer full time during I HBT working hours (9:00 Am to 5:30 PM). The engineer should be at least I TI or Diploma holder in the field of Computer Hardware with at least three years of working experience as desired. The bidder should clearly mention/submit the records in this regard during the quote.

3. The bidder may be asked to submit record of at least three past experiences in the last three years along with the quote in the field of successfully executing such kind of work in the reputed organization/ Institute along with past three ye

ars consecutive AMC's Purchase orders for the same.

4. The engineer should be equipped with proper tool kit and common freeware s oftware and diagnostic tools.

5. The bidder should routinely clean the computer and its peripherals as routine maintenance.

6. Payment mode- No advance payment shall be made. Payment shall be made on quarterly basis against bill for a quarter, after completion of that quarter only.

7. In case, the bidder fails to attend the call, the proportional amount from the bill will deducted.

8. Any dispute, if arise, will be resolved mutually only.

Payment will be made on quarterly basis after completion of quarter through RTGS.

3. Scope of Supply

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
