Tenders in double seal (tender document & EMD in separate envelopes, both envelopes sealed in one envelope) will be received in the O/o undersigned up to 3.00 P.M. on 08.07.15 and will be opened on the same day at 3.30 P.M. in the presence of tenderers, if any. The firms who have executed the work for private organizations are necessarily to produce T.D.S. certificates for issue of tenders. The firms who are not registered with H.P. Sales Tax Deptt. may also apply for issue of tenders. But such firms need to seek the said registration within one month of award of work, in case the work is awarded to them. The validity of tender will be 90 days after opening of the same. For any dispute arising in between the contract agreement, latest CPWD norms will be followed.
