



NOTICE INVITING TENDER (5-46/Ws/15), (5-45/Ws/15)

Scaled tenders are hereby invited from the contractors of appropriate class of CPWD, PWD, Railway, MES, CSIR Labs/Instts., Govt./Semi-govt. organizations and Public Sector undertakings who are registered under contract of labour (Regulation & Abolition) Act, 1970 and also have EPF Registration under the EPF Act, 1952 for providing the following lumpsum jobs/services on contract basis:

The receipt of applications supported with copies of required certificates, with H.P. Sales tax /VAT registration, labour and EPF registration and satisfactory similar work completion certificates for issue of tenders, shall be stopped by **21.05.15** Tender documents shall be issued to the eligible firms up to **22.05.15** from the O/o the undersigned during office hours on payment of tender fee. The firms who have started and completed satisfactorily the minimum one/two/three similar works (Similar works) each costing not less than ₹ 3.80 /₹ 2.85 /₹1.90 Lacs within last seven years ending on **30th April, 2015** need only to apply. Tenders in double seal (tender document & EMD in separate envelopes, both envelopes sealed in one envelope) will be received in the O/o undersigned up to 3.00 P.M. on **25.05.15** and will be opened on the same day at **3.30 P.M.** in the presence of tenderers, if any. The firms who have executed the work for private organizations are necessarily to produce T.D.S. certificates for issue of tenders. The firms who are not registered with H.P. Sales Tax Deptt. may also apply for issue of tenders, but such firms need to seek the said registration within one month of award of work, in case the work is awarded to them. The validity of tender will be 90 days after opening of the same. For any dispute arising in between the contract agreement, latest CPWD norms will be followed. Conditional tenders and tenders without full earnest money are liable to be rejected. The NIT is also available on web site www.tenderhome.com and www.ihbt.res.in.
