

The receipt of applications supported with copies of required certificates, H.P. Sales tax, VAT registration and satisfactory work completion certificates for issue of tenders, shall be stopped by **6.6.16** Tender documents shall be issued to the eligible firms up to **7.6.16** from the O/o of the undersigned during office hours on payment of tender fee. The firms who have started and completed minimum one/two similar works each costing not less than for sr. No. 1 Rs. 20.00 lacs/ Rs. 15.00 lacs, for sl. No. 2 minimum Rs. 45.00 lacs/Rs. 35.00 lacs and for sl. No. 3 Rs. 7.70 lacs/Rs. 5.80 lacs within last seven years ending on 30th April, 2016, respectively need only to apply. Tenders in double seal (tender document & EMD in separate envelopes, both envelopes sealed in one envelope) will be received in the O/o undersigned up to 3.00 P.M. on **8.6.16**. The firms who have executed the work for private organizations are necessarily to produce T.D. S. certificates for issue of tenders. The firms who are not registered with H.P. Sales Tax Deptt. may also apply for issue of tenders, but such firms need to seek the said registration within one month of award of work, in case the work is awarded to them. The validity of tender will be 90 days after opening of the same. For any dispute arising in between the contract agreement, latest CPWD norms will be followed.
