B. Scope of work:

1.	Farm Labour	Land development- breaking boulders, stones, preparation of individual plots, Nursery bed preparation in cultivated land for seed sowing and seedling transplantation, sowing with seeds and application of fertilizers in the nursery beds. Sowing in plots (preparation of potting mixture, filling, sowing, transplanting and transportation top dressing (manually). Bed preparation of field bank, Sieving of soil for polybags filling, filling of potting media in 12x25 cm polybags. Preparation of rotting media (soil +FYM + sand). Cultural operations like weeding, hoeing, disposal of waste weed material, fencing improvement due to damage of snow (barbed wire and chicken mesh wire). Green shade net poly-house preparation, harvesting of medicinal and aromatic crops roots, rhizome, including carriage to storage site and weighing. Harvesting of medicinal and aromatic crops areal part including carriage to storage site and weighing. Digging of rhizome/bulb/tuber/root crops etc. from experimental fields and local sites and carriage. Irrigation of water from source-channel Irrigation/Sprinkler system. Note: The above requirement is tentative and the actual manpower to be supplied under different categories or additional category may be more or less based on the requirement from time to time.

C. Criteria to be adopted for Technical Evaluation of Bids:

The following documents will be verified at the time of technical evaluation of bids.

- 1. Valid Labour license [under (Contract Labour (Regulation and Abolition Act, 1970)].
- 2. EPF and ESI registration.
- PAN/TAN Copy and GST registration.
- Similar work Experience (providing farm labour at high altitudes). Single contract amounting to of Rs.10.59 Lakhs or two contracts of Rs.6.62 Lakhs each or three contracts of Rs.5.29 lakhs each during the last three years.
- 5. Proof of registered office address at Lahaul & Spiti District.
- 6. Annual Turnover of last three years should not be less than 30% of estimated contract value.
- Copy of Bid Security/EMD (original to be received before bid opening).
- 8. MSME/ Startup registration (as and if applicable).

D. Instruction to Bidders:

Bidders are supposed to enter only their name and service charges (same service charge should be entered twice in both the rows) in the provided BoQ format.

Tender documents should be in two parts. Part-I should consist of all the technical documents/details as asked for and Part-II should contain signed copy of this tender document along with the price bid quoting only the Service charges (%age). Price Bid format and the technical documents should be in separate envelopes.

Scanned copy of the EMD, for an amount of Rs. 26,500/- (Rupees Twenty Six Thousand Five Hundred only) in the form of Demand Draft/Pay Order drawn in favour of Director, CSIR-IHBT, should be submitted along with the tender document and the same should reach the O/o Administrative Officer, CSIR-IHBT, Palampur, H.P. 176061 in hard copy before bid opening. MSME/Start-ups are exempted from EMD.

The tenderer should sign and stamp all the pages of the tender document. The tenderer should read the 'General Terms and Conditions'. The tenderer is advised to visit the work site at CeHAB, Ribling, Keylong on any working day to assess the nature and quantum of work before tendering and ascertain details.

E. General Terms and Conditions:

- The number of farm labour indicated in the scope of work is provisional and the numbers may be increased or decreased at the discretion of the Director, CSIR-IHBT, Palampur or his authorized representative.
- The farm labour deployed by the contractor shall not claim nor shall be entitled to pay, perks and other facilities admissible to casual, ad hoc, regular / confirmed employees of this office during the currency or after expiry of the contract.
- The farm labour deployed shall be employees of the Contractor only and their service under the contract will not in any manner entitle them for any claim towards regular employment against the Principal Employer i.e. the Director CSIR-IHBT, Palampur.
- The Contractor's profit / service charges shall be payable only on the minimum wages for the respective month.
- Similar work means providing unskilled/semi-skilled/skilled farm labour supply services at high altitudes in Central Govt./PSUs/Central Autonomous bodies and/or for CSIR or its Laboratories/Institutes.
- While quoting the Service Charge bidder's have to keep in mind the statutory deductions (i.e. GST TDS and IT TDS), as applicable from time to time, and also the case that if labours are not found locally then (s)he shall have to make arrangement for their accommodation.
- TDS and other taxes as applicable will be deducted from the Contractor's bill, as per the instructions issued from time to time by the competent authorities.
- The Contractor shall be responsible for all statutory liabilities (such as ESI & EPF etc.) and
 any breach of such laws or regulations shall be deemed to be breach of this contract.
 Contractor may be asked to produce documents to verify that these provisions/laws are
 complied with by the Contractor.
- Earnest Money will be forfeited if the contractor fails to commence the work or carryout other formalities as per the award letter for the work.

- If at any point of time it is found that the contractor has furnished false information, the Contract / Tender is liable to be cancelled.
- 11. Except quoting the service charge, in percentage only, in the Price-Bid/BoQ format, the tenderer should not write any condition or make any change, addition, alteration and modification in the printed form of tender. Conditional tenders will be rejected.
- Farm Labour Supply is exempted from GST, being agriculture and allied activities. The bidders are suggested to please take a note of it and quote accordingly.
- 13. The bidder quoting the lowest Service Charge will be taken into consideration in deciding the lowest bidder. In case of a tie in Service Charge quoted between two or more bidders, the lowest bidder will be decided on the basis of highest value contract of similar nature of work carried out during the last 3 years (Value of ongoing contracts shall not be taken into consideration).
- 14. The personnel of Contractor should observe only closed holidays in a calendar year irrespective of number of the holidays observed by the Institute as per the list given by the Institute from time to time. The closed holidays normally cover Republic Day, Independence Day, Gandhi Jayanti.
- 15. The Contractor shall be fully responsible for providing leave benefits, weekly offs, National & Festival holidays etc., to the personnel deployed. As and when any of personnel comes late or proceeds on leave or absents himself/herself, it will be the prime responsibility of the contractor to provide a suitable substitute on an immediate basis.
- The CSIR-IHBT with the consent of the contractor may modify terms and conditions of the contract as and when necessary without affecting the basic nature of his contract.
- The Quotation shall remain valid for a period of 90 days from the date of opening of Part-II (Price Bid) of the Tender.
- 18. The Contractor is required to post his/her authorized representative at the site of the work who shall receive the instructions from the authorized Officer of the Institute from time to time. All such instructions received by the authorized representative on behalf of the Contractor shall be deemed to have been received by the Contractor within the scope of this work order.
- 19. The tender is liable to be rejected, if white fluid is used anywhere in the tender document.
- Director, CSIR-IHBT, Palampur reserves the right to accept or reject the lowest, any or all the tenders without assigning any reasons.
- Micro & Small Enterprises (MSME) and Startups are exempted from submission of Earnest Money Deposit, prior experience and turnover criteria.

F. Contractor's Obligations:

- The Contractor shall provide farm labour services at CeHAB, Ribling, Keylong (L&S) as per Schedule of Work / Requirements which may be amended from time to time during the Contractual period and it shall always form part and parcel of the Contract.
- 2. The Contractor shall issue ID cards to the deployed farm labour.
- Minimum wages as fixed and revised from time to time by the office of the Chief Labour Commissioner (central) should be paid by the contractor.
- Contractor will have to submit labour license issued by the competent authority against the
 work awarded to their firm by CSIR-IHBT, Palampur within 30 days after the award of
 contract, failing which appropriate action may be taken against the Contractor.
- The Contractor will be responsible for maintenance of Registers and Records, i.e. personal
 details of the deployed farm labour, Muster Roll, Register of Wages, Register of Overtime,
 Register of Fines, Register of Advance, Wage Slip, etc., as per the extent provisions under

- various Labour Laws. Also, the Contractor will make it available to the Director, CSIR-IHBT, Palampur or his authorized representative, if they are requested to do so.
- The Contractor shall maintain complete official records of disbursement of wages / salary, showing specifically details of all deductions such as ESI, PF etc. in respect of all the staff deployed at CeHAB, Keylong.
- 7. The Contractor would deploy a Supervisor/Co-ordinator at their own cost who shall be responsible for immediate interaction with the Director, CSIR-IHBT or his authorized representative (s) so that optimal services of the persons deployed by the Contractor could be availed without any disruption. The Contractor shall also be responsible to settle the grievances of their workers promptly to avoid any disruption in the activities of the centre, if any.
- 8. The Contractor shall on a monthly basis, submit attested copies of attendance register in respect of its manpower deployed at CeHAB, Keylong and the same must be verified with the certificate of satisfactory services by the concerned Incharge/HOD before making the payment to the workers. The contractor shall attach the certified copy with the claim.
- Successful bidder shall furnish the ePBG (3% of the award value), duly pledged in favour of The Director, CSIR-IHBT, Palampur, valid for a period of 2 months beyond the completion of contract. The Security Deposit submitted in the form of ePBG shall be refunded to the Contractor within one month after satisfactory completion of the contract.
- The contractor shall be solely responsible for full compliance with the provisions of the sexual Harassment of women at workplace.
- 11. CSIR-IHBT shall not be responsible for any death, injury, damages or loss whether to the contractor or agents, representatives or its un-skilled/semi-skilled/skilled workers deployed which may result from any accident or by any other cause during operation and execution of the contract. The contractor shall indemnify CSIR-IHBT against any and all claims which may arise under the Workmen's Compensation Act, etc. or any other Act or statute having bearing over the services and for engagement of workmen directly or indirectly for performance under the contract.
- 12. The contractor will be responsible for their leave, replacement and other welfare measures and keep CSIR-IHBT indemnified against any claim made by the persons deployed by him and/or any damage caused to them.
- The Contractor shall not give any sub-contract to any other party or agency to carry out the obligation arising out of this contract.
- 14. The entire administration and establishment management in respect of the personnel deployed by the contractor for the captioned work shall be the responsibility of the contractor.
- It is the responsibility of the contractor to get all clearance(s) or otherwise, if any applicable from Competent Authority for providing manpower service.
- 16. In the event of sudden failure, neglect, dislocation or stoppage of the services by the Contractor, the CSIR IHBT may get the work done departmentally or by some other agency, at the risk and cost of the contractor, without prejudice to its rights to enforce performance in respect of the rest of the work period. The Contractor shall, in such event, pay to the CSIR-IHBT the additional cost incurred for having such work done by itself or by some other agency. CSIR-IHBT may recover the cost from the security deposit of the contractor. Without prejudice to any other rights, the CSIR-IHBT may terminate the agreement by one month notice to the contractor in writing and in such event the contractor shall have no claim for any loss or damage against the CSIR-IHBT.

- 17. The Contractor shall indemnify the CSIR-IHBT against all the monetary or other benefits to which the persons deployed by him are entitled during the period or deployment under various labour laws/statutory obligations as applicable from time to time.
- Unauthorized deductions from the wages in the name of file charges, consultancy charges, registration fee etc. will not be allowed in any circumstances.
- 19. The Contractor shall be solely responsible for its workers deployed at CSIR-IHBT including
 - · Recruitment and training of the staff.
 - Safety of staff.
 - · Maintenance of muster cum wage register, attendance records of the staff.
 - Insurance coverage of their staff against all contingencies.
 - · Redressal of grievance of workers.
 - Payment of wages along with wage slip by 7th of every month or as per labour laws and maintaining records thereto.
 - . ESI & EPF records of staff.
 - · Compliance of Labour laws.
 - Labour Welfare including their first aid and medical care.
 - The Contractor would provide necessary identity cards to its workers on duty.

G. CSIR Obligations:

- The Director, CSIR-IHBT shall have the right, within reason, to have any farm labour removed who is considered to be undesirable or otherwise and similarly the Contractor reserves the right to remove any personnel with prior intimation to the Director, CSIR-IHBT, Palampur.
- The services rendered by the Contractor shall be paid on monthly basis for the monthly executed quantities of service provided (in terms of mandays) in accordance with the rates quoted by him.
- That payment on account of enhancement/escalation charges on account of revision in wages by the appropriate Govt. from time to time shall be payable by the CSIR-IHBT to the Contractor.
- The performance security will be refunded to the Contractor within one month of the expiry
 of the contract only on the satisfactory completion of the contract.
- That the CSIR/Lab./Instt. shall reimburse the amount of GST, if any, paid by the Contractor
 to the authorities on account of the services rendered by him. This reimbursement shall be
 admissible on production of proof of deposit of the same by the Contractor or as per
 applicable rules on the subject.

H. Penalties/Liabilities:

- That the contractor shall be responsible for faithful compliance of the terms and conditions
 of this agreement. In the event of any breach of the agreement, the same may be terminated
 and the security deposit will be forfeited and further the work may be got done from another
 agency at his risk and cost.
- That the Contractor violates any of the terms and conditions of this agreement or commits
 any fault or his services are not to the entire satisfaction of officer authorized by the Director,
 CSIR-IHBT, in this behalf, a penalty leading to a deduction up to a maximum of 10% of the
 total amount of bill for a particular month will be imposed.

Termination:

This contract may be terminated on any of the following contingencies:

- 1. On the expiry of the contract period.
- 2. By giving one month's notice by CSIR-IHBT on account of:-
 - Committing breach by the Contractor of any of the terms and conditions of this agreement.
 - Assigning the contract or any part thereof to any subcontractor by the Contractor without written permission of the Lab./Instt.
 - iii) On Contractor being declared insolvent by competent Court of Law.
 - iv) Notwithstanding any other provisions made in the contract, the Director, CSIR-IHBT reserves the absolute right to terminate the contract forthwith if it is found that continuation of the contract is not in Public interest. The contractor is not eligible for any compensation or claim in the event of such cancellation.
 - v) If at any later date, it is found that the documents and certificates submitted by the Contractor are forged or have been manipulated, the work order issued to the Contractor shall be cancelled and Security Deposit issued to the CSIR-IHBT shall be forfeited without any claim whatsoever on CSIR-IHBT and the contractor is liable for action as appropriate under the extant laws.
 - During the notice period for termination of the contract, in the situation contemplated above, the Contractor shall keep on discharging his duties as before till the expiry of notice period.

J. Arbitration:

- In the event of any question, dispute / difference arising under the agreement or in connection herewith (except as to matters the decision of which is specially provided under this agreement) the same shall be referred to Delhi International Arbitration Centre for appointment of Arbitrator to adjudicate the dispute.
- The award of the Arbitrator shall be final and binding on the parties. The Arbitrator may give interim award(s) and / or directions, as may be required.

 Subject to the aforesaid provisions, the arbitration & conciliation Act, 1996 and the rules made hereunder and any modification thereof from time to time being in force shall be deemed to apply to the Arbitration proceedings under this clause.

K. Payment Procedure:

- The Contractor shall disburse the monthly salary directly into bank account of its workers on or before 7th day of the next month.
- The Contractor will have to submit their claim (along with a duplicate copy) at the earliest, completed in all respects. This Institute shall reimburse the admissible component of the bill claimed by the Contractor within fifteen days from the date of submission of the bill completed in all aspect.
- 3. The Contractor is also required to issue pay slips to all workers every month.
- All the payments to the workers are to be made through digital mode only i.e. ECS/NEFT/RTGS
 only. Also, please note that payment in cash is not allowed as per GFR 2017.
- While submitting the bill for the month, the Contractor must enclose the following documents:-
 - a) List of workers and their attendance duly verified with the certificate of satisfactory services by the concerned HODs /authorized representative of the Director, CSIR-IHBT, Palampur.
 - Break up of wages sheet showing working days, minimum wage, Gross salary, deductions, GST, Contractor profit and net payment etc.
 - Copies of authenticated documents of payments of such contributions to EPF and ESI (EPF and ESI along with payment proofs.)
 - d) Details of the amount disbursed along with payment proof, duly acknowledged by the respective manpower.
 - e) Details of GST remittance of the last month/cycle along with challan & receipt of payment, if applicable.
